Third Reading of Bylaw 969 Land Acquisition of Lot 1822, Plan 4389

> NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows:

- 1. THAT the Municipal Corporation of the Town of Fort Smith is hereby authorized to acquire a freehold interest or fee simple title in the following parcel of land from THE COMMISSIONER OF THE NORTHWEST TERRITORIES the whole of Lot 1822 Plan 4389 FORT SMITH, and as shown outlined in red on the attached sketch in "Schedule A" for certain, in consideration for the sum of One Dollar (\$1.00)
- 2.
